Pet Travel Guidelines:

1. Pet surcharge may apply
2. Extra fees may be incurred should there be significant additional cleaning required
3. A fee of \$200 will be levied on your room account if you or your guest(s) choose to bring a pet into a non-pet friendly room
4. Pets of 50lbs or less are welcome
5. Up to 2 pets allowed per room to a maximum total combined weight of 50lbs
6. Any pet more than 50lbs must approved by the General Manager of the requested hotel
7. No exotic species, no birds, no reptiles
8. Pets to receive welcome amenity on check-in
9. Pet are not to be left unattended in your room or suite unless written permission is received from General Manager
10. Pets must be kept on a leash at all times in the public areas inside as well as around the exterior of the hotel
11. Pets are not permitted in restaurants, the pool area, the health club, and meeting rooms
12. Should pet have any accidents on the premises, it is your responsibility clean-up after them. Should you require a plastic bag, please see Front Desk
13. Any damages to the room caused by your pet will be added to your credit card per these terms as well as our damage waiver as signed at time of check-in
14. Pets are not to be bathed in hotel restrooms. This can cause damage to hotel plumbing
15. Cat litter must not be disposed of in the toilet
16. Pets are only permitted to eat on a non-porous, tiled surface such as the washroom tiled floor

18. Please arrange a convenient time with Front Desk when you will be out of the room with your pets so that our housekeeping team can service your room. Pets must be removed from suite prior to housekeeping service entering, or other arrangements must be made with hotel management
19. Each individual hotel reserves the right to limit the number of pet-friendly rooms available as well as the category these rooms are within
20. Hotel shall not be held responsible for any illness, loss or damage, however caused to the pet
21. Guide dogs will be given access to all guest areas including public spaces and restaurants
22. Pacrim Hospitality Services Inc. reserves the right to add, delete or modify rates and information at any time at their discretion.
